This notice, together with our Terms of Use, sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us.

Information Collected

Data collected in the UK is held in accordance with the General Data Protection Regulation (GDPR). Information we collect about you when you visit our website

This Analytics data is not tied to personally identifiable information. We therefore do not collect or store your personal information (e.g. your name or address) so this information cannot be used to identify who you are. Information Use and legal basis for processing
